*Pursuant to the provisions of section 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of amendments to its articles of incorporation.*

**FIRST:** Amendments adopted:  
**Articles V and VI amended to read as follows:**

**ARTICLE V OPERATIONS**

Notwithstanding any other provision of these By-laws, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

**ARTICLE VI CORPORATION DISSOLUTION**

Should the Society become inactive or disband, as a result of a vote of the membership, three members shall be designated by the Board as Trustees. The Trustees shall liquidate the assets of the Society prudently, and pay all existing debts and liabilities in proportion to the final available capital including and money rightfully due to members. All proceeds remaining after debt settlement shall be donated to a non-profit charity as determined by the Trustees within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of Escambia County, Florida, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

**Articles VII and VIII added to read as follows:**
