ARTICLES OF INCORPORATION OF FAMILIES & FENCES MINISTRIES, INC. A FLORIDA NON-PROFIT CORPORATION

Article 1. Name. The name of the Corporation is: Families & Fences Ministries, Inc.

Article 2. Duration. The duration of the Corporation is perpetual.

Article 3. Purposes. The purposes of the corporation is as follows:

A. This is a non-stock, non-profit organization applying for exemption under The Federal Tax Code 501(c)(3). Said corporation is organized exclusively for charitable, religious and educational purposes for ministry to primarily but not limited to inmates and/or their families, including for such purposes evangelizing through prison ministry (ie: seminars, revivals, guest speaking etc.) as allowed and arranged with prison systems as well as evangelism to the family of inmates through ministry (ie: seminars, revivals, guest speaking, retreats etc.) and distribution of religious educational material, regardless of the form in which materials may be published, including but not limited to books, periodicals, newsletters, tapes, discs and software. Purpose also extends but is not limited to pastoral counseling.

B. To exercise all rights and powers conferred by the laws of the State of Florida upon nonprofit corporations.

C. Provided, however, that the corporation shall not engage in any actions which is not permitted to be carried on by nonprofit corporations under the Internal Revenue Code and no part of the net earnings of the Corporation shall inure to the benefit or be distributable to it's members, directors, or officers; but the Corporation shall be authorized and empowered to pay reasonable compensations to these people for services rendered, and to make payments and distributions to furtherance of it's stated purposes.

Article 4. <u>Members</u>. This corporation shall have no members.

<u>Article 5.</u> <u>Initial Registered Agent and Office.</u> The initial registered agent is : <u>Mary Robin Trotter</u> and the initial registered office <u>4150 Canoe Creek Rd. Saint Cloud Florida</u> 34772. (FLORIDA)

Article 6. Initial Board of Directors. The initial Board of Directors shall have <u>5</u> members whose names and addresses are:

The Bylaws shall provide the method of election of all Directors, and the number of Directors may be raised or lowered by amendment of the bylaws but shall in no case be less than three.

Article 7. Officers. The officers of the corporation shall consist of a President, Secretary, and Treasurer. Other officers may be provided for in the Bylaws. Each Officer shall be elected by the Board of Directors (and may be removed by the Board of Directors) at such and in such manner as may be prescribed in the Bylaws.
