Pursuant to the provision of section 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of amendment to its articles of incorporation.

**FIRST:** Amendment adopted:

Article 11. Dissolution of the Corporation. On the dissolution or winding up of the corporation, it's assets remaining after payment of, or provision for payment of, all debts and liabilities of this corporation shall be distributed to a nonprofit fund, foundation, or corporation which is organized and operated exclusively for charitable purposes and which established its tax-exempt status under Internal Revenue Code Section 501(c)(3).

**SECOND:** The date of adoption of amendment was: March 23, 1998
