THE STATE OF Florida
COUNTY OF POLK

KNOW ALL MEN BY THESE PRESENT

That we, citizens of the County of Polk and the State of Florida, under the provisions of the Civil Statutes of the State of Florida, do hereby form and incorporate ourselves into a voluntary religious association for the purposes of establishing and maintaining religious worship, providing a religious atmosphere for the education of children, and offering services to sustain the elderly, and to that end adopt the following:

ARTICLE I

This corporation shall be known as Cornerstone United Pentecostal Church,^{Inc.} by which name it shall contract, be contracted with, sue and be sued and shall transact all of its business.

ARTICLE II

The street address of its registered office is 912 East Parker Street, Lakeland Florida 33801 and the name of its initial registered agent at such address is Kelly McGuire. The mailing address is P.O. Box 92176 Lakeland, Florida 33804

ARTICLE III

This corporation is formed for the primary purpose of establishing and maintaining religious worship

ARTICLE IV

The secular affairs of this organization shall be under the oversight and management of the Board of Trustees/Advisors, also known as the Board of Directors, subject always to the approval of the members of this organization. Said Board of Trustees/Advisors shall hold title to all property of this corporation, such property to be held for the use and benefit of the members of this corporation. Said Board of Trustees/Advisors shall not usurp or exercise the functions of any person in charge of the spiritual affairs of the Cornerstone United Pentecostal Church, Lakeland, Florida.

Said Board of Trustees/Advisors shall be comprised of not fewer than three (3) nor more than five (5) members, and the same shall be elected by nominated by the Pastor/Chairman and ratified by the members of the corporation.

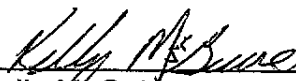
