ARTICLES OF INCORPORATION OF

The undersigned incorporator(s), for the purpose of forming a corporation under the Florida NOT FOR PROFIT Corporation Act, hereby adopt(s) the following Articles of Incorporation.

ARTICLE I - NAME AND PRINCIPAL OFFICE

The name of the corporation is Haitian Church of Brothers Unity in Jesus Christ, Inc. and its principal office is located at 5219 N State Rd 7, Tamarac, Florida 33319.

ARTICLE II - Existence

This corporation shall commence its existence on January 1, 1998.

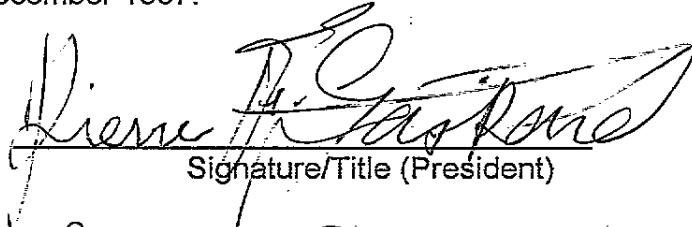

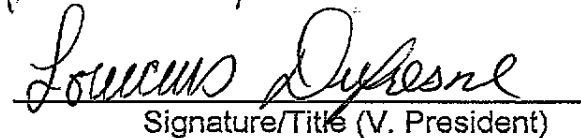
