ARTICLES OF INCORPORATION OF LEGAL AID SOCIETY of SOUTH CENTRAL FLORIDA, INC. A FLORIDA NONPROFIT CORPORATION

ARTICLE I

The name of the Corporation is Legal Aid Society of South Central Florida, Inc.

ARTICLE II

The duration of the Corporation is perpetual.

ARTICLE III

The purpose of the Corporation is as follows:

This is a not-for-profit corporation organized under Florida Statutes Chapter 617, the Florida Not For Profit Corporations Act, formed for the purpose of providing legal aid.

ARTICLE IV

The Corporation is organized and shall be operated on a non-stock basis within the meaning of Florida Statutes Chapter 617, the Florida Not For Profit Corporation Act. The Corporation shall not have the power to issue shares of any type or class of stock. The Corporation may issue membership certificates if so provided in the Bylaws. The Corporation may have one class of voting members. The Bylaws of the Corporation shall set forth the qualifications, rights and privileges of the voting members. The Bylaws may provide for one class of Nonvoting members whose qualifications, rights and privileges shall be set forth in the Bylaws.
