ARTICLES OF INCORPORATION OF LEGAL AID SOCIETY of SOUTH CENTRAL FLORIDA, INC. A FLORIDA NONPROFIT CORPORATION

ARTICLE I

The name of the Corporation is Legal Aid Society of South Central Florida, Inc.

ARTICLE II

The duration of the Corporation is perpetual.

ARTICLE III

The purpose of the Corporation is as follows:

Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code. This is a not-for-profit corporation organized under Florida Statutes Chapter 617, the Florida Not For Profit Corporations Act, formed for the purpose of providing legal aid.

ARTICLE IV

No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by any organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, corresponding section of any future federal tax code, or (b) by any organization, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code. The Corporation is organized and shall be operated on a non-stock basis within the meaning of Florida Statutes Chapter 617, the Florida Not For Profit Corporation Act. The Corporation shall not have the power to issue shares of any type or class of stock. The Corporation may issue membership certificates if so provided in the Bylaws. The Bylaws may provide for one class of Nonvoting members whose qualifications, rights and privileges shall be set forth in the Bylaws.

The Bylaws shall provide the method of election of all Directors. The number of Directors may be increased or decreased by amendment to, or in the manner provided in the Bylaws, but the Corporation shall never have fewer than three (3) Directors. The Bylaws shall set forth the method of selection for the Chairman of the Board.

ARTICLE VII

The officers of the Corporation shall consist of a President, Secretary and Treasurer. Other officers may be provided for in the Bylaws. Each Officer shall be appointed by the Board of Directors for such terms and in such a manner as set forth in the Bylaws. The Bylaws shall set forth the duties of each Officer. The same individual may simultaneously hold more than one office.

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
