

**Article I. NAME**

**LEE COUNTY PULLING TOGETHER (LCPT), INC.**

**Article II. ADDRESS**

**Article III. PURPOSES**

The purposes for which the **LEE COUNTY PULLING TOGETHER (LCPT), INC.** is organized are exclusively religious, charitable, scientific, literary and educational within the meaning of section 501 (c) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States of Revenue Law.

Notwithstanding any other provisions of these article, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501 (c) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code of 1986, or corresponding section of any future Federal tax code, or shall be distributed to the Federal, state, or local government for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the organization is then located, exclusively for that purpose.

**Article IV. MEMBERSHIP**

There shall be one class of membership open to all persons regardless of race, color, creed, religious belief or age upon filling out application and having that application accepted by the Board of Directors and/or the membership at large pursuant to the by-laws determined by the Board of Directors.


**Article V. BOARD OF DIRECTORS
