The undersigned, desiring to form a corporation not for profit under Chapter 617 of the Florida Statutes, does ordain and establish these articles of Incorporation.

**ARTICLE I**

The name of the corporation is **ADOPT A NEIGHBOR, INC.**

**ARTICLE II**

The street address of the principle office of the corporation is 222 Steedly Ave., Lake Wales, Florida 33853 and the mailing address of the corporation is also 222 Steedly Ave., Lake Wales, Florida 33853.

**ARTICLE III**

The purposes for which the corporation is organized are as follows:

(a) volunteer service that will provide help to homeowners who are financially, mentally, or physically unable to do various things for themselves. All services of the corporation are to be provided without charge to the homeowner. Services will be provided through volunteers. Financial donations as well as supplies will be accepted.

(b) To provide services and other benefits without regard to race, age creed, color or national origin.

(c) To promote the health and welfare of the community.

**ARTICLE IV**

The method of election of directors of the corporation shall be as stated in the bylaws of the corporation, as amended from time to time.
