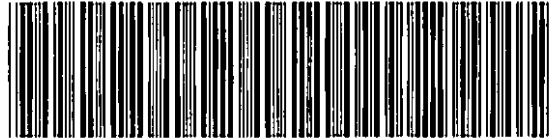


RESOLVED, that Christian Vision USA, Inc. shall change its corporate name to CV Americas, Inc.


