In compliance with the requirements of the Florida Not For Profit Corporation Act, undersigned, desiring to incorporate a nonprofit corporation, hereby certifies that:

ARTICLE I:

The name of the Corporation is Search Dogs South of Florida, Inc.

ARTICLE II:

ARTICLE III:
