The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I - NAME

The Name of this corporation is Color Me Human Cultural Festival, Inc.

ARTICLE II - PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be 2125 SE Ft. King Street, Ocala, Florida 34471.

ARTICLE III - PURPOSE

This not for profit corporation is organized for the purpose of conducting the business of providing a cultural conference and festival, and to promote tolerance of ethnic and cultural diversity.

ARTICLE IV - Manner of Election of Directors

There shall be a minimum of five Directors and a secretary and treasurer, and they shall be elected by the executive committee of the Color Me Human Festival Board. New Directors will be elected only in the event of the voluntary resignation of current directors/executive committee, or the removal of a current director by a majority vote of the rest of the board of directors.

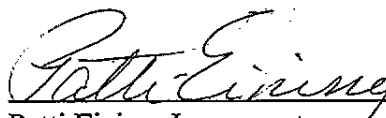
