ARTICLES OF INCORPORATION

OF

SHRINE OF THE MASTER, INC.

A Non-Profit Corporation

We, the undersigned, for the purpose of forming a non-profit corporation under Section 501(c)(3) of the Internal Revenue Code, do hereby certify:

ARTICLE L NAME

The name of this Corporation is SHRINE OF THE MASTER, INC.

ARTICLE II. PRINCIPAL PLACE OF BUSINESS

The principal place of business and the mailing address of this corporation shall be: 2717 Browning Street, Sarasota, Florida 34237.

ARTICLE III. PURPOSES

The general nature of the objects and purposes of this Corporation shall be:

- (A) That this corporation is a religious corporation and is not organized for the private gain of any person. It is organized under the Nonprofit Benefit Corporation Law exclusively for religious purposes.
