ARTICLES OF INCORPORATION

The undersigned, acting as incorporator(s) of a corporation pursuant to chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation:

ARTICLE I

Name

The name of the corporation shall be:

Restorative Justice Outreach Ministries, Inc.

ARTICLE II

Principal place of business and mailing address

ARTICLE III

Purpose(s)

The specific purpose(s) for which the corporation is organized is(are):

To assist local communities with establishing *Victim Offender Reconciliation Programs*. These provide offenders and their victims with the opportunity to discuss and address those issues associated with a wrongdoing. A primary goal is to arrive at some form of compensation to the victim. Examples of wrongdoing that may be eligible for *Restorative Justice Victim Offender Reconciliation* include: vandalism; fighting; making obscene phone calls; harassing individuals, and property damage. *Restorative Justice Outreach Ministries* offers an alternative to traditional court proceedings.

Additionally, *Restorative Justice Outreach Ministries, Inc.* assists individuals with resolving disputes in the family, workplace, neighborhood and organizations.

Services Provided for Victims of Crime and their Offenders

Mediation: A volunteer mediator (neutral third party) brings the victim and offender together in a shared problem solving process called *mediation*. During this meeting, the mediator helps ensure that the facts of the case are discussed, restitution negotiated, and an agreement signed, stating the nature and amount of restitution agreed upon. After the meeting, the agreement and a written summary are sent to the referral agency for approval and enforcement. *Victim Offender Mediation* may be used in judicial and non judicial cases. It may be used alone, or as a component of another program, for example, the Juvenile Alternative Sentencing Program, Community Control, and probation. *Restorative Justice* also may be used in detention centers, residential and non residential programs, correctional facilities, etc.

Services Provided for Resolving Disputes in the Family, Workplace, Neighborhood and Organizations

Mediation services are offered to interested individuals, religious organizations, civic groups, businesses, schools, youth clubs, churches, etc.

When mediation may be used: Tenant-landlord disputes; consumer complaints; student-teacher disputes; parent-teacher disputes; disagreements within religious organizations; husband-wife; parent-child; and property and neighborhood disputes.

Other Services Provided

Through *seminars and workshops*, the following also are offered:

1. ***Creative conflict resolution*** for adults and youth. Exercises stress problem-solving skills; developing a cooperative attitude; and communication skills. Seminars and workshops are appropriate for civic groups, educational, religious and work place settings.
2. ***Mediation training*** teaches adults and youth how to help other individuals resolve their disputes. Listening, leadership, and negotiation skills are emphasized.

ARTICLE IV Manner of election of directors
