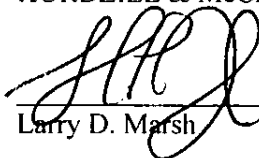

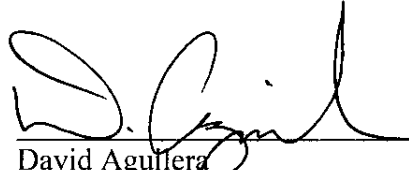
4. That all debts, obligations, and liabilities of the corporation have been paid or discharged or that adequate provision has been made therefor.

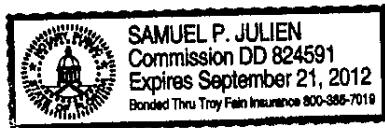

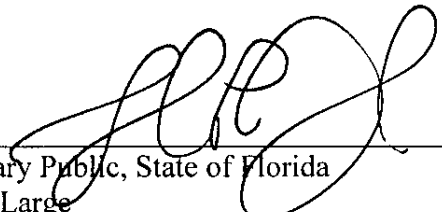

## **PLAN OF COMPLETE LIQUIDATION AND DISSOLUTION**

### **OF**

#### **NEW RAMAN RETI SCHOOL, INC.**

This Plan of complete liquidation and dissolution, hereinafter called the "Plan", is for the purpose of effecting the complete liquidation and dissolution of New Raman Reti School, Inc., a Florida corporation not for profit hereinafter called the "Corporation," through the distribution of the assets of the Corporation to Bhaktivedanta Academy of North America, Inc., a Florida corporation not for profit that is a school within the International Society for Krishna Consciousness hereinafter called "Bhaktivedanta," in complete liquidation and in accordance with Article VI of the Corporation's Articles of Incorporation.

(1) This Plan shall be considered adopted by the Corporation when it has been approved by the board of directors of the Corporation.

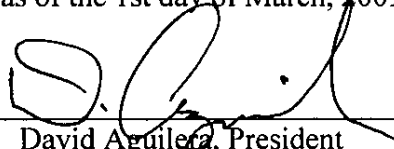
(2) After this Plan has been adopted and approved, the remaining assets of the Corporation shall be distributed to Bhaktivedanta, after making provision for the Corporation's liabilities and obligations. Such distribution shall be accomplished in the manner and on the terms which are best suited to the needs of the Corporation.

(3) As soon as practicable after the distribution of all of the assets of the Corporation to Bhaktivedanta in complete liquidation, the officers shall file Articles of Dissolution of the Corporation with the Secretary of State of Florida, together with this Plan.

(4) The officers and directors of the Corporation are authorized, empowered, and directed to adopt any subsequent resolutions to effectuate the intent of the Corporation and the shareholders of the Corporation to liquidate the Corporation in accordance with this Plan of

liquidation and to execute and file on behalf of the Corporation all documents that they may deem necessary or advisable to carry out the purposes and intentions of this Plan.
