FOR

NEW LIFE COMMUNITY CHURCH OF BROWARD COUNTY, INC.

A NONPROFIT CORPORATION

We, the undersigned, with other persons being desirous of forming a nonprofit corporation, under the provisions of Chapter 617 of the Florida Statutes, do agree to the following:

ARTICLE I

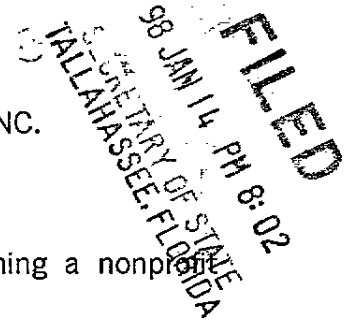
The name of the Corporation shall be NEW LIFE COMMUNITY CHURCH OF BROWARD COUNTY, INC. The address of the principal office of this corporation shall be 2424 N. Federal Highway, Suite 454, Boca Raton, Florida 33431, and the mailing address of the corporation shall be the same.
