ARTICLES OF INCORPORATION

OF

GREATER RIDGECREST AREA BOARD OF DIRECTORS, INC.

*The undersigned, acting as incorporators of a not for profit corporation pursuant to Chapter 617, Florida Statutes, adopt the following Articles of Incorporation:*

ARTICLE I

Name

The name of the not for profit corporation shall be:

ARTICLE II

Principal Place of Business and Mailing Address

ARTICLE III

Purposes

The specific and primary purpose of Greater Ridgecrest Area Board of Directors is to provide services, activities and programs.

in the Greater Ridgecrest Area that will instill community pride and set the framework for a future filled with success and growth.

It is intended that this corporation shall operate as a qualified section 501(c)(3) corporation under the Internal Revenue Codes for the purpose of providing services, activities and programs to improve the educational, recreational, physical and social activities among residents of the Greater Ridgecrest community in order to promote the social welfare of the community; to engage in activities that will raise the standard of civic morality and community welfare; and to foster good will and mutual understanding among the members of the Greater Ridgecrest Area.

#### **ARTICLE IV**

##### **Manner of Election of Directors**

The manner in which the directors are elected or appointed shall be set forth in the bylaws of the corporation.

#### **ARTICLE V**

##### **Limitation of Corporate Powers**

The not for profit corporation is authorized to exercise all powers as set forth in section 617.0302, Florida Statutes, as long as said powers are consistent with those purposes which will qualify it as an exempt organization under section 501(c)(3) of the Internal Revenue Code of 1986 or corresponding provisions of any subsequent federal tax laws, including, for these purposes, the making of distributions to organizations which qualify as tax-exempt organizations under that Code.

This not for profit corporation shall not, as a substantial part of its activities, carry on propoganda or otherwise attempt to influence legislation; nor shall it participate or intervene (by publication or distribution of any statements or otherwise) in any political campaign on behalf of any candidate for public office.

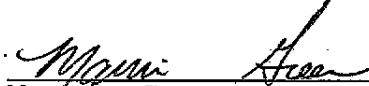
