ARTICLES OF INCORPORATION

The undersigned subscribers to this Charter, each a natural person, competent to contract, hereby associate themselves together to form a corporation not for profit under the laws of the State of Florida.

ARTICLE I

The name of this Corporation shall be "Florida Association of Condominiums Inc."; its principal office shall be at street address 1132 Carissa Drive in the City of Tallahassee, County of Leon, State of Florida, Zip Code 32308, and other offices may be maintained elsewhere as may be found expedient.

ARTICLE II

The general nature of the objects of this Corporation shall be: To encourage, support, and inform the condominium owners and business enterprises of Florida and afford a medium for their cooperation in support of constructive policies relating to all matters affecting them and for their protection against unjust action from any source; To advocate fair and equitable legislation affecting the welfare of its members; To encourage good will, harmony and fair dealing among its members; To obtain, possess and disseminate information pertaining to any and all matters of interest or moment to its members; and, to promote the general welfare and prosperity of the Commonwealth of Florida as a whole; To acquire, own, lease, mortgage, sell and convey all such property, real and personal, and to have and exercise all such powers, as may be necessary or convenient to the accomplishment of the general objects herein set out; and, to have and exercise all the rights, powers, and privileges granted and permitted corporations not for profit by the laws of the State of Florida.

ARTICLE III

Any person, firm or corporation shall be eligible to membership and to conduct business with the Florida Association of Condominiums.

ARTICLE IV

This Corporation shall exist perpetually.


Amendments to these Articles of Incorporation may be proposed and amended at the discretion of the Officers listed under ARTICLE VII.


