a Florida Not for Profit Corporation

The undersigned persons, acting as incorporators of a corporation not for profit under the Florida Not for Profit Corporation Act, as set forth in Chapter 617 of the Florida Statutes, adopt the following Articles of Incorporation for such corporation:

ARTICLE I - NAME

The name of the Corporation is:

GENERATION FORCE . INC.

ARTICLE II - DURATION

The duration of the Corporation shall be perpetual.

ARTICLE III - PURPOSE

The Corporation is a not for profit corporation. The Corporation is formed for the purpose of providing Educational Opportunities to young people promoting abstinence.

ARTICLE IV - NON-STOCK CORPORATION

A. The Corporation is organized upon a nonstock basis as defined in Section 617.011 of the Florida Statutes.

ARTICLE V - PRINCIPAL OFFICE

ARTICLE VI - INITIAL REGISTERED OFFICE AND AGENT

ARTICLE VII - BOARD OF DIRECTORS

The powers of the Corporation shall be exercised, its property controlled, and its affairs conducted by a board of directors. The manner of selection of the members of the Board of Directors shall be established in the Bylaws of the Corporation.

- A. <u>INITIAL BOARD OF DIRECTORS</u>. The Corporation shall have FOUR (4) Director(s) initially. The number of Directors may be either increased or diminished from time to time by appropriate amendment to the bylaws but shall never be less than three.
- B. **DIRECTOR'S ACTIONS**. Any action required or permitted to be taken by the board of directors under any provision of law may be taken without a meeting, of all the directors shall individually or collectively consent or consents in writing to such action. Such written consent or consents shall be filed with the minutes of the proceedings of the board, and any such action by written consent shall have the same force and effect as if taken by unanimous vote of the directors. Any certificate or other document filed under any provision of law that relates to action so taken shall state that the action was taken by unanimous written consent of the board of directors without a meeting and that the articles of incorporation [and bylaws] of this Corporation authorize the directors to so act. Such a statement shall be prima facie evidence of such authority.

C. <u>ELECTION AND REMOVAL OF DIRECTORS</u>. The method of election and removal of directors shall be set forth in the bylaws.
