ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF

FLORIDA ASSOCIATION OF LEGAL SPECIALISTS, INC.

The Articles of Incorporation of FLORIDA ASSOCIATION OF LEGAN SPECIALISTS, INC. heretofore approved and filed in the office of the Secretary of State of Florida on January 16, 1998, Document No. N9800000254, pursuant to Section 617.1006 of the Florida Not For Profit Corporation Act, is hereby amended in the following particulars:

1. Article I of the Articles of Incorporation is amended to read as follows:

"ARTICLE I

"The name of the corporation is FLORIDA ASSOCIATION OF LEGAL SUPPORT SPECIALISTS, INC."

2. The foregoing amendment was adopted by the directors and members at a meeting held on the 18th day of July, 1998, and the number of votes cast for the amendment was sufficient for approval.
