Articles of Incorporation

Article 1. Name. The name of the corporation is:

Living By Faith, Inc.

Article 2. Duration. The duration of the corporation is perpetual.

Article 3. Purposes. The purposes of the corporation are as follows:

A. This is a non-stock, non-profit organization applying for exemption under The Federal Tax Code 501(c)(3). Said corporation is organized exclusively for charitable, religious and educational purposes for ministry to primarily but not limited to listeners of Living By Faith radio broadcast ministry, including for such purposes as encouraging, teaching, evangelizing through Living By Faith broadcast ministry (i.e. radio, TV) as well as evangelism to others through teaching, speaking, and distribution of educational materials, regardless of the form in which materials may be published, including but not limited to books, periodicals, newsletters, and tapes. Purpose also extends to pastoral counseling.

B. To exercise all rights and powers conferred by the laws of the state of Florida upon nonprofit corporations.

C. Provided, however, that the corporation shall not engage in any actions which are not permitted to be carried on by nonprofit corporations under the Internal Revenue Code and no part of the net earnings of the corporation shall inure to the benefit or be distributable to its members, directors, or officers; but the corporation shall be authorized and empowered to pay reasonable compensations to these people for services rendered, and to make payments and distributions to furtherance of its stated purposes.

Article 4. Members. This corporation shall have no members.

Article 5. Initial Registered Agent and Office. The initial registered agent is:

The Bylaws shall provide the method of elections of all Directors, and the number of Directors may be raised or lowered by amendment of the Bylaws but shall in no case be less than three.

Article 7. Officers. The officers of the corporation shall consist of a President, Secretary, and Treasurer. Other officers may be provided for in the Bylaws. Each Officer shall be elected by the Board of Directors (and may be removed by the Board of Directors) at such and in such manner as may be prescribed in the Bylaws.
