The undersigned, acting as incorporator(s) of a corporation pursuant to chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation:

ARTICLE I

The name of the corporation shall be: MIRACLE CENTER FELLOWSHIP MINISTRY, Inc.

ARTICLE II

ARTICLE III

The purpose of this ministry is to provide Christian guidance in everyday living. 
