**ARTICLES OF INCORPORATION**

**ARTICLE I - NAME**

The name of the corporation shall be Immaculate Heart of Mary Roman Catholic Chapel, Inc.

**ARTICLE II - PRINCIPAL OFFICE**

The principal place of business shall be : 2404 East Stuart Street, Tampa, Florida 33605

**ARTICLE III - PURPOSE**

The purpose of the corporation is to safeguard the Traditional Latin Mass and Sacraments of the Roman Catholic Church as directed by the Council of Trent and promulgated by Pope St. Pius V in accordance with the Council of Trent.

**ARTICLE IV - MANNER OF ELECTION OF DIRECTORS**

Section 1. The Board of Directors shall consist of seven members. Directors shall be elected by members of the Chapel on the last Sunday in December. The first election of Directors will be for a term of two years for four Directors and a term of one year for three Directors. After the first election, Directors will serve a term of two years, so that each year part of the Board of Directors will carry over to provide continuity. All Directors will be Tridentine Roman Catholic Traditionalists. Board members can be re-elected to serve two additional terms.

Section 2. The Board of Directors will elect a Chairman at the first meeting of the years. The Chairman will serve a term of one year and will serve at the pleasure of the Board of Directors.

**ARTICLE IV - MANNER OF ELECTION OF DIRECTORS (Continued)**

Section 3. Vacancies by resignation or otherwise will be filled by the Board of Directors at the first meeting of Directors, after "Notice of Vacancy" is published for four consecutive Sundays.

Section 4. Failure of a Director to attend two consecutive meetings of the Board, after documented receipt of notice of scheduled meeting, shall be construed as resignation by said Director. Upon determination the Board shall appoint another to fill the vacancy for the remainder of the term.

Section 5. The Board of Directors shall meet at least quarterly or upon call by the Spiritual Director/Chaplain or the Chairman.

**ARTICLE V - DISSOLUTION**

Upon dissolution of the corporation, upon consultation with the Chapel's Spiritual Director/Chaplain, all assets will be granted to a traditional Roman Catholic Society, whose purpose is to safeguard the Traditional Latin Mass and Sacraments of the Roman Catholic Church as directed by the Council of Trent and promulgated by Pope St. Pius V in accordance with the Council of Trent.
