ARTICLES OF INCORPORATION

ARTICLE I

NAME

The name of this corporation shall be THE PHILIPPINE CENTENNIAL MOVEMENT OF FLORIDA, U.S.A., INC.

ARTICLE II

DURATION

This corporation shall have perpetual existence commencing with the filing of these Articles of Incorporation by the Secretary of State of the State of Florida.

ARTICLE III

CORPORATE NATURE

This is a non-profit corporation organized solely to promote and propagate Philippine Centennial Movement Chapters throughout the State of Florida for purposes of promoting cultural, educational, charitable and civic programs, events and activities involving individual Filipino-Americans and organizations' participation in the Philippine Centennial Celebrations.

ARTICLE IV

GENERAL AND SPECIFIC PURPOSES

The specific and primary purposes for which this corporation is formed are:

ARTICLE V

ARTICLE VI

EARNINGS AND ACTIVITIES OF CORPORATION

None of the net earnings of this corporation shall inure to the benefit of any member, individual person, firm or corporation; provided, however, that this shall not operate to prohibit the payment of salaries and operating expenses, as approved by the Board of Directors. All the net earnings of this corporation shall be devoted exclusively to charitable, educational, cultural, civic or recreational purposes and priority projects locally and in the Philippines.
