## ARTICLES OF INCORPORATION

### ARTICLE I

#### NAME

The name of this corporation shall be THE PHILIPPINE  
CENTENNIAL MOVEMENT OF FLORIDA, U.S.A., INC.

490 MARTIN ROAD - MARGATE, FLORIDA 33068

### ARTICLE II

#### DURATION

This corporation shall have perpetual existence commencing  
with the filing of these Articles of Incorporation by the Secretary  
of State of the State of Florida.

### ARTICLE III

#### CORPORATE NATURE

This is a non-profit corporation organized solely to promote  
and propagate Philippine Centennial Movement Chapters throughout  
the State of Florida for purposes of promoting cultural, educational,  
charitable and civic programs, events and activities involving individual  
Filipino-Americans and organizations' participation in the Philippine  
Centennial Celebrations.

## ARTICLE IV

### GENERAL AND SPECIFIC PURPOSES

The specific and primary purposes for which this corporation is formed are:

- A. To promote and propagate the Philippine Centennial Movement throughout the State of Florida.
- B. For the promotion of cultural heritage, civic, charitable, educational and any other related purposes.
- C. For enhancement of Philippine Culture through folkdances, music, community events and activities highlighting the Philippine Centennial.
- D. Encourage active participation and involvement and unity among Filipino American community.

## ARTICLE V

### MEMBERSHIP

The corporation shall promote and authorize individual and corporate supporters through memberships of various types and categories to generate people resource and financial support; and also to raise funds in order to implement priority programs, projects and activities locally and in the Philippines.

## ARTICLE VI

### EARNINGS AND ACTIVITIES OF CORPORATION

None of the net earnings of this corporation shall inure to the benefit of any member, individual person, firm or corporation; provided, however, that this shall not operate to prohibit the payment of salaries and operating expenses, as approved by the Board of Directors. All the net earnings of this corporation shall be devoted exclusively to charitable, educational, cultural, civic or recreational purposes and priority projects locally and in the Philippines.

ARTICLE VIII  
BOARD OF DIRECTORS

The powers of this corporation shall be exercised, and the affairs of this corporation conducted by a Board of Directors. The number of directors and the manner of their selection shall be as set forth in the By-Laws, but the number of directors shall never be less than three (3). It is also the intention of this corporation to distribute part of its assets upon dissolution to charitable organizations in the Philippines.

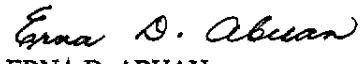

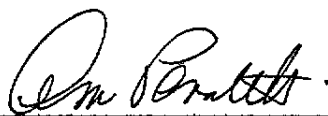
