OF

WE, the undersigned with other persons being desirous of forming a corporation for charitable purposes under the provisions of Chapter 617.0202 of the Florida Statutes do agree to the following:

ARTICLE I  
NAME & ADDRESS

The name of the corporation shall be:  
THE MOST SACRED HEART FOUNDATION, INC.,  
a Florida not for profit corporation.

ARTICLE II  
TERM OF EXISTENCE

This corporation is to exist perpetually.

ARTICLE III  
COMMENCEMENT OF EXISTENCE

The corporation shall be deemed to commence its existence on the date of filing and assignment of charter number.

ARTICLE IV  
PURPOSES

The corporation is organized as a not for profit foundation exclusively for charitable purposes. The specific purposes of the corporation are:

- a) To establish, receive and maintain a fund or funds for the support of Socio-Legal Services and Developing Countries; to that end, to take and receive by gift, grant, bequest, devise or otherwise any and all property of any sort or nature, without limitation as to amount or value, and to manage, administer, invest, reinvest, and dispose of the same; to establish and administer endowment funds; from time to time pay and apply the fund and property of the corporation, including the principal as well as income thereof, for the support of Socio-Legal Services and developing Countries;
- b) Subject to the limitations and conditions contained in

any gift, devise or bequest, to invest its funds in such mortgages, bonds, debentures, shares of preferred and common stock and other securities and properties as its directors shall deem advisable, and to that end to purchase, sell, mortgage, lease, pledge, encumber, assign and transfer the same;

c) To the extent permitted by law, to do everything necessary or proper for the carrying out of the foregoing purposes.

#### ARTICLE V QUALIFICATION OF MEMBERS

The sole Member of this corporation shall be Myriam Mézadiou, as foundress of the foundation, a corporation sole.

#### ARTICLE VII OFFICERS

Section 1. The officers of the corporation shall be a President, one Vice President, a Secretary, a Treasurer any additional Assistant Secretaries or Treasurers, and such other officers as may be provided in the Bylaws. A person may hold more than one office at one time.

Section 2. The names of the persons who shall serve as Officers of the corporation until the first meeting of the Board of Directors are:

ARTICLE VIII  
BOARD OF DIRECTORS

The business of this corporation shall be managed by the Board of Directors. This corporation shall have three directors initially. The number of directors may be increased or decreased from time to time, in accordance with the Bylaws but shall never be less than three. The sole Member of this corporation shall appoint the Directors. The sole Member may remove any and all of the Directors from the Board, with or without cause and at any time such time as she may determine in her sole discretion.

ARTICLE IX  
BYLAWS

The sole Member of this corporation shall adopt the Bylaws for the conduct of the Corporation's business and the carrying out of its purposes as she may deem necessary.

The Bylaws may be amended, altered or rescinded by the sole Member of this corporation at any regular meeting or special meeting called for that purpose.

ARTICLE X  
AMENDMENTS

These Articles of Incorporation may be amended by the sole Member of this corporation at any regular or special meetings called by the sole Member for that purpose.

ARTICLE XI  
CONDUCT OF AFFAIRS

The business and affairs of the corporation shall be conducted in a manner consistent with the Code of Do Good To And Love All, the religious directives of The Most Sacred Heart, all applicable directives and teachings of the Roman Catholic Church, and the provisions of the Articles of Incorporation and Bylaws of this corporation.

ARTICLE XII  
LIMITATIONS ON ACTIVITIES

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to, its members, directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes of the corporation. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting, to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate or public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on a) by a corporation exempt from Federal income tax under Section 501 (c) (3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law); or b) by a corporation, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law.


ARTICLE XIII  
DISTRIBUTION OF ASSETS UPON DISSOLUTION

No person, firm or corporation shall ever receive any dividends or profits from the undertaking of this corporation and upon dissolution of this foundation all of its assets remaining after payment of all costs and expenses of such dissolution shall be distributed to organizations selected by the sole Member which have qualified for exemption under Section 501 (c) (3) of the Internal Revenue Code and none of the assets will be distributed to any member or officer or director of this corporation, provided, however, that the corporation may confer benefits in the form of distributions, in dissolution or otherwise, upon a not-for-profit corporate member described in Section 501 (c) (3) of the Code.
