ARTICLES OF INCORPORATION

OF

IGLESIA VIDA ABUNDANTE PENTECOSTAL INC.

(TRANSLATION) PENTECOSTAL CHURCH OF ABUNDANT 1-1PE

(NON FOR PROFIT)

We, the undersigned individuals of the State of Florida, all of whom are of legal age, each being competent or contract, hereby from ourselves and our successors into a corporation non for profit under the laws of the State of Florida, and hereby adopt the following Articles of Incorporation.

ARTICLE I NAME:

The name of this corporation shall be: IGLESIA VIDA ABUNDANTE PENTECOSTAL INDENTECOSTAL CHURCH OF ABUNDANT LIFE INC. (TRANSLATION), to wit its principal place of business is located at 301 Westward Drive Miami Springs, Fl. 33166, Dade County. The name and address of the Registered Agent is:

ARTICLE II PURPOSE

The general nature, object and purpose of this corporation is as follows: To establish and maintain a place of worship of Almighty God, our Heavenly Father to proide for Christian fellowship for those of like precious faith, where the holy ghost may be honored according to our distinctive testimony; to assumw our share of responsibility and the priviledge of propagating the gospel of Jesus Christ by all available means, both at home and abroad.

ARTICLE III PROPERTY

The corporation shall have the power to buy, acquire, and hold title in fee simple, in trust, or otherwise, to both real and personal property, and improve, encumber, sell, convey, and dispose of all such property, to borrow money, execute notes, bonds, and other evidences of indebtedness and to secure the same by mortgages and deeds of trust, annuity bond, and other instruments of indebtedness and to pay interest thereon, to improve, adapt, and use property held by it or the income therefrom in the religious, educational, benevolent, or social activities of the corporation or its successors without financial profit to its membersexcept as may be necessary in the payments of salaries, and or other compensation for services rendered, and the Corporation shall have the power to erect and maintain buildings to be utilized by said church, for the worship of God, for the training in Christian faith, and to build and maintain residences for the use and occupance of the ministers of: In conformity with the by laws of said corporation and all power or right granted to the Non For Profit Corporation under the laws of the State of Florida.

ARTICLE IV MEMEBERSHIP

The member of the corportion shall be all members in good standing at any given time in the State of Florida, provided however, neither the incorporators nor the members of the

corporation shall have any vested right, intereest, or priviledge of, in or to the assets, functions, affairs or franchises of this corporation, or any right, interest or priviledge which may be inheritable, or shall continue after his/her membership ceases in the afornamed corporation. This corporation shall not have the power to buy, mortgage sell, encumber or deed or dispose of any property which it may acquire, eithout the consent or the direction of a Two-Three (2/3) majority vote of the officers, or its successor.

Members are considered as all persons who come to the church at least once a week.

ARTICLE V TERM

This corporation shall exist perpetually or until dissolved by due process of the law. Should this corporation ceases to exist as a legal entity and its charter be terminated, title to all its property automatically shall become vested in the conference of the State of Florida, as it holds title to any other property of the Sate of Florida.

ARTICLE VII OFFICERS

The officers who are to manage the affairs of this corporation shall be as follows: A President, Secretary, and Vice Pres., a Treasurer, which shall be the trustees of the corporation, and such other officers shall be provided for in by the by-laws, all of whom shall constitute and be the Official Board of Directors.

They shall be elected from time to time in accordance with the by laws, and each shall hold office until his successor is elected and qualified, at its regular annual meeting. The President shall sign and the Secretary shall attest all legal contracts authorized by the member of this corporation and the laws of the State of florida.

ARTICLE VIII BY-LAWS

The by-laws of this corporation are to be made, altered by a majority of the qualified members present and voting at any property called business meeting at which a quorum is present.

ARTICLE IX AMENDMENT

These articles of Incorporation may be amended in the manner provided by law. Every amendment must first be approved by the Official Board of Directors, (trustees) then approved at a duly constituted meeting called for, two weeks in advance, by the members, by a majority of those entitled to vote thereon.
