

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I.

NAME OF CORPORATION

The name of the corporation shall be: THE ROUGH RIDERS OF NORTH FLORIDA, INC.

ARTICLE II.

PRINCIPAL OFFICE

The initial principal place of business and mailing address of this corporation shall be: 204 South Monroe Street, Tallahassee, 32301.

ARTICLE III.

NATURE OF BUSINESS

The purpose of this corporation shall be to participate in the Springtime Tallahassee Grand Parade, held annually in and about Tallahassee, Florida, and to engage in any other civic, social, fraternal, or cultural purpose, or such other purpose permissible under section 617.0301, Florida Statutes.
