ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation:

ARTICLE I NAME:

- C. To transact any other lawful business for which not-for-profit corporations may be incorporated under Florida General Corporation Act or engage in any other trade or business which can, in the opinion of the Board of Directors of the Corporation, be advantageously carried on in connection with the forgoing process.

ARTICLE IV MANNER OF ELECTION OF DIRECTORS:

The manner in which the directors are elected or appointed is:
Directors and Officers are elected annually by the members. Members shall be eligible for election to the Board of Directors as prescribed by the organization's By-Laws, rules and regulations.
