ARTICLES OF INCORPORATION
OF
REY DE REYES Y SENOR DE SENORES, INC.

The undersigned, acting as incorporators of a corporation pursuant to chapter 617, Florida Statutes, adopts the following articles of incorporation:

ARTICLE I

The name of the corporation shall be Rey de Reyes Y SENOR DE SENORS,

ARTICLE II

ARTICLE III

The specific purposes for which the corporation is organized are:

A quorum for the holding of a meeting of the Board of Directors, and for other operations properly carried out by the Directors on behalf of the Corporation, shall consist of majority of the members thereof, but the directors, by unanimous consent in writing, included in the minutes of the corporation, may consent to the doing of any act and such consent in writing shall have the same force and effect as though a formal meeting had been held pursuant to call being duly made and as though the said act had been completed and authorized at a meeting at which a quorum had been present, and/or such duties may be delegated to an "Executive Committee".

The corporate powers of this corporation are as provided in section 617.0302, Florida Statutes.
