ARTICLE I

NAME

The name of the corporation shall be The Russtar Foundation, Inc.

ARTICLE II

NATURE OF BUSINESS

The nature of business of this corporation shall be: the operating of a non-commercial radio station to serve community needs.

Any activities authorized by law in the State of Florida and in the United States of America for a not for profit corporation.

ARTICLE III

TERM OF EXISTENCE

This corporation shall have perpetual existence.

ARTICLE IV

AMENDMENT


These Articles of Incorporation may be amended in the manner provided by law. Every amendment shall be approved by the Board of Directors.

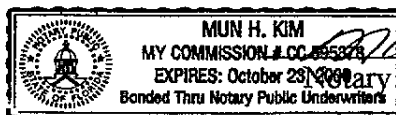
