

ARTICLES OF INCORPORATION FOR NON-PROFIT ORGANIZATION

OF

FIRST ST. PAUL MISSIONARY BAPTIST CHURCH, INC.

The undersigned, for the purpose of forming a non-corporation under the Florida Non-Profit Corporation Act, Chapter 617, Florida Statutes, do hereby adopt the following articles of incorporation:

ARTICLE ONE - NAME

The name of the corporation is FIRST ST. PAUL MISSIONARY BAPTIST CHURCH, INC., 730 Clark Street, Baldwin, Florida.

ARTICLE TWO - DURATION

The duration of the corporation is perpetual unless dissolved according to law. Corporate existence shall commence on the date of filing.

ARTICLE THREE - PURPOSE

This non-profit corporation is organized solely for general religious purposes pursuant to the Florida Corporation Not for Profit Law as set forth in Section 617 of the Florida Statutes. The specific and primary purposes for which this non-profit corporation is formed are:

a) To support and promote the preaching of the Gospel with the different language population of the universe; conduct crusades, train and equip God-call evangelists; plant churches; support missionaries; meet human needs; and whatever way the Holy Spirit leads, for the advancement of religious education and any other related or corresponding charitable purposes by the distribution of its funds for such purposes. To worship, honor and teach the whole world the Jesus is Christ our Lord and Savior and the belief of one true and self-existing God. Further, to establish Christian schools, colleges, pre-schools and day care centers under the Department of Christian education. To establish, support, promote and maintain halfway and rehabilitative facilities, homeless shelters, soup kitchens for the feeding of the hungry on a daily basis, alcohol and drug abuse assistance facilities, battered and abused women facilities, facilities for counseling for teen pregnancies, unwed mothers and fathers, for

church social services, retreats, revivals, ex-con assistance, counseling services for marriages, drug and alcohol, crisis, pastoral, behavioral, youth and school tutoring.

b) To promote, foster, and further Christian characteristics and interest in Christianity, not only in this locality, but elsewhere, without restriction as to time and place.

c) To operate exclusively in any other manner for such religious, charitable, and educational purposes as will qualify it as an exempt organization under Section 501(c)(3) of the Internal Revenue Code of 1954, as amended, or under any corresponding provision of any subsequent federal tax laws, covering the distribution to organizations qualified as tax exempt organization under the Internal Revenue Code, including private foundations and private operating foundations.

ARTICLE FIVE - REGISTERED OFFICE AND AGENT

The principal office and registered office address of the corporation is: 730 Clark Street, Baldwin, Florida 32234, and the name of its initial registered agent at such address, is Reverend Johnny McCoy Boone, who has signed the appropriate Acceptance which is attached hereto.

ARTICLE SIX - DIRECTORS

The number of directors constituting the initial board of directors of the corporation is five. The name and address of each person who is to serve as a member of the initial board of directors is, all of whom shall be elected by the Board of Trustees:

Membership to this christian organization shall be set forth in the By-Laws.


ARTICLE ELEVEN - DISSOLUTION



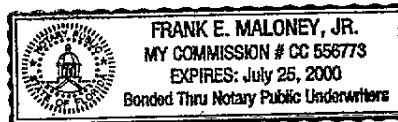
