**ARTICLES OF INCORPORATION**

(National Council of the Pure)

The undersigned, acting as incorporators of a corporation pursuant to chapter 617, Florida Statutes, adopts the following Articles of Incorporation:

**ARTICLE I**

The name of this corporation shall be: "Concilio Nacional de los Puros, Inc."

**ARTICLE II**

The principle place of business and mailing address of this corporation shall be: 4678 E. Colonial Drive, Orlando, Florida 32803-4357.

**ARTICLE III**


