

Amendment to Article III of the Articles of Incorporation for Concilio Nacional De Los Puros, Inc.

The purpose for which this Corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Florida Corporations Act and the Florida Not For Profit Corporation Act that are organized for such purposes as follows:

The objective of Concilio Nacional De Los Puros, Inc. is to serve as a philanthropic corporation dedicated to raising monies, both public and private, to create and establish, in partnership with the community, a community center dedicated to the following:

1. To create and develop programs for Hispanic youth which will encourage them to become productive members of the community-at-large thereby eliminating the potential for juvenile delinquency.
2. To raise monies to create and develop programs designed to assist individuals of Hispanic origin with medical needs, and/or social service needs that are not being met via normal avenues.
3. To assist members of the Hispanic community who, as a result of a catastrophic situation find themselves in need of a variety of services, including, but not limited to, legal services, financial assistance, food, shelter, etc.

This Corporation shall be organized exclusively for charitable purposes and shall be authorized to exercise the powers permitted Not For Profit Corporations under Chapter 617, the Florida Not For Profit Corporation Act, of the Florida Statutes; provided, however, that this Corporation, in exercising any one or more of such powers, shall do so in the furtherance of the exempt purpose for which it has been organized, as described in section 501(c)(3) of the Internal Revenue Code.
