#### ARTICLE I - NAME

The name and address of the Corporation are TWELVE (12) TRIBES FOUNDATION, INC. 227 1st Street, Suite # 3, Miami Beach, Florida 33139.

### ARTICLE II - CORPORATE PURPOSE

Section 2: The Officers of the Corporation shall be a President, one or more vicepresidents, a Treasurer, an Assistant Treasurer, a Secretary, and an Assistant Secretary.
