ARTICLES OF INCORPORATION OF MT. OLIVE FREE WILL BAPTIST CHURCH, INC.

We, the undersigned persons of the State of Florida, each being competent, hereby form ourselves and our successors into a corporation not-for-profit under the statues of the State of Florida, and do hereby adopt the following Articles of Incorporation as our charter.

Article I

The name of this corporation shall be the "Mt. Olive Free Will Baptist Church, Inc., with its principal place of business located at 3313 S. Combee Road, Eaton Park, Florida 33840-0368 in Polk County.

Article II

This Corporation shall exist perpetually.

Article III

This first purpose for which this corporation is organized is to create a Christ centered environment for the promotion of the anointing of the Holy Spirit, a life of Holiness, and Spirit-fill preaching and teaching of the full written word of God.

The second purpose for which this corporation is organized is to further the spiritual, numerical and financial growth of Mt. Olive Free Will Baptist Church, Inc.

The third purpose for which this corporation is organized is to carry forward the massage of the gospel to the community via a Christian Book Store, Christian Academy, School of Ministry, Word-Base Christian Education, Christian Discipline, Christian Benevolence and other future ministries.

Article IV

Article VI

The names of the first officers of this corporation are as follows:

Donald A. Horne, Sr. - Pastor/President Vida Register - Treasurer Ella Horne - Clerk/Secretary Charles Denson - Head Deason Chattiemae Johnson - Head Trustee Mary Ann Collins - Head Mother Martha Wilson - Head Prayer Intercessor

Article VII

The position of pastor, shall be Chief Spokesman and Chief Executive Officer. He shall have general oversight of the church. The boards, departments, auxiliaries, ministries, officers and members shall be subject to the pastor's direction in accordance with the by-laws of the church and laws of the Free Will Baptist Church.

Article VIII

The names of the first member of the Trustees ministry are as follows:

Article IX

The over all protection of and maintenance of properties of this corporation (also know as "The Church") shall be the primary responsibility of the trustees ministry. The trustees shall also be the guardians of the Constitution, by laws and other legal papers of the Corporation.

Article X

The trustees ministry shall be constituted in the following manner; No less than (3) three and no more than (11) eleven members. These members shall be selected by the Pastor, however a vote of approval or disapproval shall be required of the church. The trustee like the deacons shall serve one year at a time; and annual recommendation by the Pastor and approval vote of the Church shall be required for a new year of service.

Article XI

The Head Deacon, Head Mother, Head Trustee and all offical group heads shall be appointed by the Pastor Annually as directed by the law of the Free Will Baptist Church and by-laws of Mt. Olive Free Will Baptist Church, Inc.

Article XII

The deacons shall minister to the needs of widows, orphans, the hungry, the naked, the sick, the needy and the prisoners. The deacon ministry, may help the Trustee ministry from time to time upon request or directions of the Pastor however the primary duties of the deacons must be to care for the physical need of the membership of the church and assist the pastor as needed. The deacons like the trustees shall serve one year at a time; an annual recommendation by the Pastor and approval vote of the church shall be required for a new year of service.

Article XIII

Members of the finance ministry shall be elected once a year with no less than three (3) members. The treasurer shall be in charge of the ministry. The ministry shall served for one year per recommendation of the Pastor and require an approval or disapproval vote of the church.

Article XIV

The Pastor shall declare in December of each year all position within the church, (except that of Pastor) to be vacant and open. It shall be the Pastor's responsibility to fill all vacancies by a recommendation committee or appointments as needed, however all positions shall require an approval or disapproval vote of the majority vote (50% + 1) of church membership in good standing present for the meeting (giving special regard to position performance, qualification, christian character and systematic giving of Tithes and Offerings to the church weekly.

Article XV

The qualifications for membership and the manner admission shall be govern by the by-laws, however all new members must complete a new member orientation and a Pastoral Consultation before becoming a voting member, receive the right hand of fellowship or hold a position in the church upon approval of the church.

Article XVI

Any member who neglects his or her duties to the church or absents himself or herself from the church for 90 days without an acceptable notice to the church and pastor, or fails to weekly support the church financially and in regular attendance no less than two (2) Sundays per month (unless server illness family emergency or work schedule) or willfully violate the by-laws of the church, or the laws of the Free Will Baptist Church then he or she shall be considered not in good standing and inactive until satisfaction is given to the church and pastor. If no satisfaction is given the member's name shall be remove from the church roll after 90 days and have the right hand of fellowship withdrawn.

Article XVII

The core by-laws of this Corporation shall be called the "Book of Fellowship" and the "Covenant Of Fellowship".

Article XVIII

The by-laws of Mt. Olive Free Will Baptist Church maybe amended by a 50% + 1 vote of the church. However a vote of 1/3 of the membership in good standing of Mt. Olive Free Will Baptist Church, Inc. must be in attendance at a meeting called by the Senior Pastor of the Church, before the article(s) may be amended.

Article XIX

Upon dissolution of winding up of the Corporation, any assets remaining after payment of debts, of the Corporation shall be disbursed to the "United American Free Will Baptist Church Conference, Inc." or another Christian body by majority vote 50% + 1 of members in good standing present.

Article XX
