ARTICLES OF INCORPORATION
OF
FAITH LOVE OUTREACH MINISTRY INC.

Whereas, the word of God is the complete, infallible, and final authority over the entirety of creativity including man;

Whereas, the word of God addresses the entirety of man's relationship to both God and man: and whereas, the word of God places upon the elders fall responsibility and accountability to God for the direction and leadership of the church which they are overseeing:

Therefore, the undersigned, acting as incorporator of a corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation.

ARTICLE I
Name

The name of this corporation shall be: **Faith Love Outreach Ministry, Inc.**

ARTICLE II
Principal Place of Business and Mailing Address

The principal place of business of this corporation shall be located at 2691 Tina Lane, Middleburg, FL 32068. The mailing address of this corporation shall be: P.O. Box 375, Doctors Inlet, FL 32030.

ARTICLE III
Purposes

The purposes of this corporation are as follows:

- A. To adopt, live by, and minister the word of God in its entirety as canonized and derived from the original Hebrew and Greek languages as the constitution and by laws of Faith Love Outreach Ministry, Incorporated.
- B. To maintain the church's inherent rights to sovereignty in the conduct of life in accordance with the Article of Incorporation and voluntarily enters into cooperative fellowship with the Body of Christ.

- C. To provide basic New Testament discipleship to all; to bring pleasure to our heavenly Father by our purity of heart and obedient nations; and to be a catalyst in changing our world through daily infiltration at every level and function of our society with the gospel of Jesus Christ.
- D. To perform the sacraments of the church which include, but are not limited to: The baptism of believers in water by immersion, the celebration of the Lord's supper, the anointing of the sick with oil, the conducting of weddings and funerals.
- E. To ordain persons to the ministry. To establish and maintain other churches, or other institutions or ministries and to send forth and maintain ministers for the establishment and upbuilding of such churches, or institutions, either domestic or foreign. Such institutions shall be of a religion, charitable, or educational purpose as described in section 501(c)(3) of the Internal Revenue code of 1954 (or the corresponding provision of any future United States Internal Revenue Law). They shall include but are not limited to: bible schools, bible colleges, christian day care centers, christian schools, homes for the aged, indigent, widows, orphans, alcoholics, drug addicts, or other persons in need of the necessary provisions of life.
- E. Receive tithes, offerings, gifts, bequests, and other income and to solicit funds and raise money to fulfill the purposes of this corporation. To borrow money, issue bonds debentures, notes or other obligations, secure monies so borrowed or in payment for property, or for any of the purposes of this corporation.

The foregoing shall not be construed to limit the purposes of this corporation or in any way inhibit this corporation from doing or undertaking any other purpose lawfully authorized in Section 617.0302, Florida Statutes or other applicable law.

ARTICLE IV

Manner of Election of Directors

The directors of this Corporation will be elected by the members at annually meeting in accordance with the ByLaws of this Corporation.
