**ARTICLE VII LIABILITY**

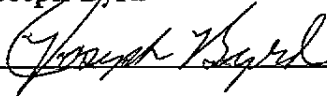

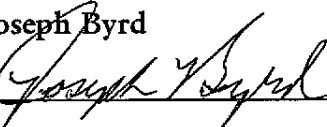
