Dear Sirs:

The incorporation of our Gainesville Osteoporosis Support Group should be terminated.

The enclosed copies give more information about it, including the old address. Betty Ann and I--she did most of the work with my assistance--moved three months ago to Jacksonville. No one in Gainesville is able or willing to continue the group, and we failed two attempts to get tax exemption from the Internal Revenue Service.

I have filed Florida tax returns prepared by H. and R. Block for 1997 and 1998.

After all bills are paid, any remaining funds (possibly \$1,500) will be given to a clinic in Gainesville to provide bone density tests to women who cannot afford them (\$100 to \$200 each) or for research in osteoporosis as soon as we can locate a good recipient.

Perhaps some day another group will provide information about osteoporosis and more bone density tests which give the only sure diagnosis. Such a group can hopefully provide this to the poor black women on the east side of Waldo Road in Gainesville, which still has vestiges of racial segregation.
