The undersigned, for the purpose of forming a Corporation under the Florida General Corporation Act, hereby adopt(s) the following Articles of Incorporation:

ARTICLE I
Name

The name of the Corporation is Florida Buddhist Society, Inc.

ARTICLE II
Duration

The term of existence of the corporation is perpetual.

ARTICLE III
Purpose

The purpose for which this corporation is organized is to enhance understanding of Buddhism through joint programs of religious, educational, social, and cultural nature sponsored by various Buddhist organizations.

ARTICLE IV

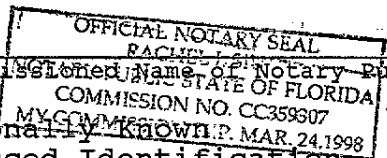
