ARTICLES OF INCORPORATION

OF

L'ASSOCIATION CHRETIENNE EN ACTION POUR LA RECHERCHE
DES AMES PERDUES INC.

I.

The name of this corporation is L'ASSOCIATION CHRETIENNE EN ACTION POUR LA RECHERCHE DES AMES PERDUES, A NONPROFIT CORPORATION. INC.

II.

The term for which this corporation shall exist shall be perpetual.

III.

The general nature of the business or businesses to be transacted by said corporation shall be as follows:

To foster, support, and engage in activities relative to religious concepts, goals, and ideals, including any and all activities which are lawful and appropriate in accordance with the tenets of Christianity and the laws of the State of Florida. The church shall engage in activities and programs that serve its congregation and the community at large, and which serve to promote religion, human development, mutual understanding, and public service.

That of engaging in any activity permitted under the laws of the United States of America, its territories, districts, and possessions, and any activity permitted under the laws of the State of Florida, and to have, exercise, and enjoy the powers and privileges granted to corporations not for profit by Chapter 617, Florida Statutes.

To do all and everything necessary, suitable, and proper for

the accomplishment of any of the purposes, of the attainment of any of the objects, or for the furtherance of the powers herein set forth, either alone or in association with other corporations, firms, or individuals, and to do every other act or acts, thing or things, incidental or appurtenant to or growing out of or connected with the aforesaid business or powers, or any part thereof; provided, that the same be not inconsistent with the laws under which this corporation is organized.

The purposes for which the L'ASSOCIATION CHRETIENNE EN ACTION POUR LA RECHERCHE DES AMES PERDUES, ^{INC.} is organized are exclusively religious, charitable, scientific, literary, and educational within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

Notwithstanding any other provision of these Articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

IV.

Officers/Directors shall be qualified for admission, and shall be admitted as Officers/Directors, in accordance with the by-laws of this corporation; a two-thirds vote of the membership shall be required for the election of new Officers/Directors or for the removal of current directors.

V.

The street address of the initial registered office of this corporation is: 800 N. E. 80 Street, Miami, Florida 33138, and the initial registered agent at that address is: Rochenel Polydor.

VI.

This corporation shall have as directors initially those persons designated in this Article below. The number of directors may be either increased or decreased from time to time by the By-Laws, but shall never be less than three (3) nor more than five (5).
