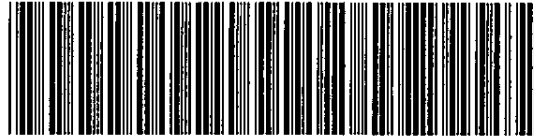

### **ARTICLE III**

#### **PURPOSE**

This Corporation is organized exclusively for charitable and educational purposes. More specifically; to promote the welfare of miniature and other pigs, to assist in the rescue and placement of abused, neglected, abandoned or unwanted miniature and other pigs; to educate the general public with respect to the true nature and characteristics of miniature and other pigs; to promote the health and welfare of the miniature and other pigs; and to provide a means by which pig owners can exchange information and join in common activities to further promote the health and welfare of miniature and other pigs. To this end, the Corporation shall at all times be operated exclusively for charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as now enacted or hereafter amended, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code of 1986, as now enacted or hereafter amended.

All funds, whether income or principal, and whether acquired by gift or contribution or otherwise, shall be devoted to said purposes.
