IN THE NAME OF CHRIST OUR REDEEMER, CHRIST OUR LORD WE THE UNDERSIGED DO HERBY. ASSOCIATE, OURSELVES TOGETHER TO FORM AND ESTABLISH A CORPURATION NOT FOR PROFIT UNDER THE LAWS OF THE STATE OF FLORIDA

WE FUTHER DO HEREDY ADOPT AND AGREE TO THE FOLLOWING ARTICLES.

IV.


