ARTICLES OF INCORPORATION
OF
NEW JERUSALEM WORSHIP MINISTRIES, INC.,
a Florida Nonprofit Corporation

The undersigned natural person, for the purpose of forming a nonprofit corporation under the Florida Nonprofit Corporation Act, does hereby adopt the following Articles of Incorporation.

ARTICLE I

Name

The name of the corporation is NEW JERUSALEM WORSHIP MINISTRIES, INC.

ARTICLE II

Principal Office

The principal office of the corporation is located at 1960 U.S. 1 South, Suite 102, St. Augustine, Florida 32086.

ARTICLE III

Purpose

The corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under §501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

The purpose of the corporation is:

- a) To inform individuals of the saving gospel of the Lord Jesus Christ;
- b) To stimulate the total development of one's spiritual, mental, and physical potential, enabling them to enjoy a more abundant life of love, salvation, peace, prosperity, health and happiness through the eternal God;
- c) To invoke policies that will allow members to share in the material and spiritual blessings of the church;
- d) To establish health, social, and educational programs in conjunction with the ministry of the church;
- e) To establish branches all over the world to proclaim the everlasting gospel for the purpose of bringing souls into the kingdom of God;
- f) To affiliate with other churches and organizations with similar beliefs and objectives without losing our identity;
- g) To ordain those individuals who having a call of God, living a consistent Christian life and having the Baptism of the Holy Spirit; preaching only the gospel that Jesus Christ preached; and
- h) To further the ministry of the church by means of modern communication methods for the purpose of achieving the aims and objectives of the church.

ARTICLE IV

Duration

The corporation shall have perpetual existence.

ARTICLE V

Membership

The authorized number and qualifications of the members, the manner of their admission, the different classes of membership, if any, the property, voting, and other rights and privileges of members, and their liability for dues and assessments and the method of collection thereof, shall be set forth by the bylaws.
