The undersigned incorporator, for the purpose of forming a corporation pursuant to the laws of the State of Florida under the Florida Not for Profit Corporation Act providing for the formation, liability, rights and privileges and immunities of a Not for Profit Corporation hereby adopts the following Articles of Incorporation:

ARTICLE I

Name of Corporation

The name of the corporation shall be: SOUTH FLORIDA CHAPTER WGSDCII, INC.

ARTICLE II

Purpose

The purpose of this corporation is to engage in the business of a Not for Profit Recreational Dog Club as permitted under the laws of the United States and in the State of Florida.

ARTICLE III

Duration

This corporation shall have perpetual existence.

ARTICLE IV

Incorporator

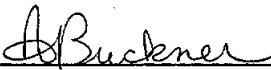

Amendment

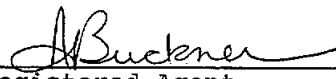
