ARTICLES OF INCORPORATION

OF

LIVING WORDS OF LIFE MINISTRIES, INC.
(A Corporation Not For Profit)

We, the undersigned incorporators of Living Words of Life Ministries, Inc. of Tallahassee, Florida, being desirous of forming a corporation for religious purposes under the provisions of Chapter 617, Florida Statutes, do hereby form this corporation not for profit and hereby agree and adopt the following Articles of Incorporation.

ARTICLE I

Name

The name of this corporation shall be LIVING WORDS OF LIFE MINISTRIES, INC.

ARTICLE II

Address

The location of this corporation shall be 3617 Old Bainbridge Road, Tallahassee, Florida.

ARTICLE III

Purpose

The purpose for which this corporation is organized is religious, including the organization and maintenance of a church to preach the gospel for the betterment of all humankind and to perform any and all legal functions related to such purpose.

ARTICLE IV

Qualification of Members

The qualification of members and the manner of their admission shall be as follows:

(a) All members of LIVING WORDS OF LIFE MINISTRIES, INC., of Tallahassee, Florida, on the date of the issuing of the charter to the corporation shall be members of this corporation.

(b) All other members of this corporation shall be admitted only by action of the members of the corporation as described in the by-laws of this corporation.

ARTICLE V

Term of Existence

The term for which this corporation shall exist shall be perpetual.

ARTICLE VIII
By-Laws

Upon proper notice the by-laws may be amended, altered, or rescinded by a majority vote of the Board of Directors at any regular meeting or any special meeting called for that purpose.

ARTICLE IX
Amendments

These Articles of Incorporation may be amended at a special meeting of the membership called for that purpose, by a majority vote of those present, provided notice has been given as required in the by-laws.

Amendments may also be made at a regular meeting of the membership upon notice given, as provided in the by-laws, of intention to submit such amendments.

ARTICLE X


This corporation accepts and adopts the provisions of the "Florida Not For Profit Corporation Act," Chapter 617, Florida Statutes.

ARTICLE XI
Distribution of Assets Upon Dissolution

No person, firm or corporation shall ever receive any dividends or profits from the undertaking of this corporation, and upon dissolution of this association all of its assets remaining after payment of all costs and expenses of such dissolution shall be distributed to organizations which have qualified for exemption under Section 501(c)(3) of the Internal Revenue Code, or for a public purpose, and none of the assets will be distributed to any member, officer or director of this corporation.
