ONE: The name and address of this principal corporation is MT. MORIAH YOUTH

COMMUNITY CENTER 16900 SW 100 AVE. Miami, Florida 33157 in Dade County.

The Corporation is organized pursuant to the FLORIDA Nonprofit Corporation Code.

TWO: This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. The corporation is organized under the Nonprofit Public Benefit Corporation Law, for charitable and educational purposes to aid and feed the poor and disadvantaged individuals and families towards a life of self-sufficiency, The programs will consist of but shall not be limited to: Seminars, Outreach Advocacy Programs for the Homeless and Disadvantaged, Health Care, Housing, Employment, Literacy. Substance Abuse Awareness and Prevention, Tutoring, AIDS Awareness, Elderly Care and other programs to aid those in need.

**THREE:** The duration of this corporation shall be perpetual, no stock and shall have no members.
