The undersigned, acting as incorporator of a corporation pursuant to chapter 617, Florida Statutes, adopt the following Articles Of Incorporation:

ARTICLE I

The name of the corporation shall be: B'nai Yeshua Messianic Synagogue Inc.

ARTICLE II

The period of duration of this corporation is perpetual beginning with the date of filing.

ARTICLE IV

The specific purpose of B'nai Yeshua Messianic Synagogue Inc., is to establish and maintain a consist place for worship and teaching of the gospel of Yeshua The Messiah ,to both Messianic Jews and Gentiles, from the Holy scriptures who desire to worship the G-d of Israel in spirit, truth and a Jewish setting.

ARTICLE V

B'nai Yeshua will hold weekly Shabbat meetings at various locations depending on the availability of such locations and upon the approval of its executive board.

ARTICLE VI
