The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following ARTICLES OF INCORPORATION:

ARTICLE ONE: NAME - The name of the proposed corporation shall be: RAINBOW OF LIFE, INC. The principal place of business of the corporation shall be: 740 N. Magnolia Ave., Orlando, FL 32803.

ARTICLE TWO: DURATION - The duration of the corporation is perpetual.

ARTICLE THREE: PURPOSE OF BUSINESS - The corporation is organized to solicit funds to allow for terminally ill patients and their families to take vacations.

ARTICLE FOUR: The provision for qualification of members and the manner of their admission is to be provided for in the bylaws.

ARTICLE SEVEN: This corporation is organized under a non-stock basis.
