The undersigned incorporator, for the porpose of forming a corporation not for porfit under the laws of the State of Florida, hereby adopts the following Articles of Incorporation.

ARTICLE I

NAME

ARTICLE III

PURPOSE

The purposes for which the Corporation is organized are to maintain and operate the EVANGELIC BAPTIST CHURCH EBEN-EZER OF NAPLES, Inc., for the furtherance and teaching of religious ideas and beliefs, for worship, to foster a sense of community amongst the Baptist population of Naples and surrounding areas, and not for pecuniary profit. DEDICATION OF ASSETS

Upon dissolution of this organization, after payment of all debts, no part of the remaining assets may be distributed to any trustee, officer or member of the corporation but shall be distributed as the By-Laws may direct in accordance with law, provided, however, that the distribution must be to another organization exempt under the provisions of Section 501 (c) (3) of the Internal Revenue Code as in existence in 1998, or any corresponding Section of said Code as subsequently amended, or to the United States, State of Florida, or local government for a public purpose.
